2.0 SCOPE OF WORK

3.0 Terms and Conditions:

Terms of delivery: Free Delivery at Site including loading/unloading.

Delivery period: The Delivery Period/Time shall be essence of the Contract and delivery must be completed not later than 07 days from the date of PO.

Taxes and Duties: Contract Prices are all inclusive i.e. including all taxes, duties, local levies / transportation / loading-unloading charges etc. Break up of GST shall be indicated by the bidder while raising invoice / bill. While submitting the bill / invoice bidder shall undertake that the Goods and Services Tax (GST) charged on this bill is not more than what is payable under the provision on the relevant Act or the Rules made there under and that the Goods on which GST has been charged have not been exempted under the GST Act or the Rules made thereunder and the charges on account of GST on these goods are correct under the provision of that Act or the rules made there under.

Octroi Duty and / or other local taxes: Contract Prices are on all-inclusive basis hence no reimbursement over and above the contract price(s) shall be allowed to seller towards payment of local taxes (such as levy of town duty, Octroi Duty, Terminal Tax and other levies of local bodies etc).

Limitation of Liability: The provisions of limitation of liability between Buyer and Seller as given in the GTC shall be applicable here.

Resolution of disputes: In case of any dispute the same shall be mitigated as per provision of the tender and territorial jurisdiction shall be within the limit of the Hyderabad Court.
